Announcement Federal Treasury discount paper (Bubills)

According to the issuance schedule of the German Federal Government for the second quarter of 2023 the following Bubills will be reopened by a multi-ISIN auction on 3 April 2023:

Reopening Federal Treasury discount paper (Bubills) July 2022 issue / maturity 12 months ISIN DE0001030864 Current volume : € 13 billion Due on 19 July 2023 Residual maturity: 3 months (105 interest days)

Reopening Federal Treasury discount paper (Bubills) January 2023 issue / maturity 12 months ISIN DE000BU0E014 Current volume : € 9 billion Due on 17 January 2024 Residual maturity: 9 months (287 interest days)

A total amount of \in 6 billion is envisaged for the reopened Bubills (including respective retention quote) with a planned share of \in 2 billion for the Bubill July 2022 issue (ISIN DE0001030864) and \in 4 billion for the Bubill January 2023 issue (ISIN DE000BU0E014). The effective increase amount of each Bubill will be determined as part of the auction allotment on 3 April 2023.

Members of the Bund Issues Auction Group are entitled to bid. Bids are to be submitted through the Bund Bidding System BBS and must be for a par value of not less than \leq 1 million or an integral multiple thereof. The price bids must be expressed in terms of full 0.00005 percentage points. Non-competitive bids are possible. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the bids accepted. The right to scale down bids is reserved.
