# Announcement of auction Reopening 10-year Federal bond

As already announced in the issuance calendar for the third quarter of 2024, the Federal Government will reopen once again the

**2.60 % bond of the Federal Republic of Germany of 2024 (2034)**  
issued on 3 July 2024 - ISIN DE000BU2Z031

on 21 August 2024, using an auction procedure. An increase of € 4.5 billion is envisaged for the issue (auction allotment and retention quote). The current volume of the bond amounts to € 10 billion. Members of the Bund Issues Auction Group are entitled to bid.
